We provide a **miniaturized enterprise asset management (mEAM) system** for small government contractors and small defense subcontractors

**MyPropertyID** provides a globally unique identification number (UIN), license tag, for government furnished property (GFP). Our strategy ties UINs to customers at time of order. License tags with corresponding UINs are delivered via USPS, then affixed to serialized items

We provide automated front-end, backend and fulfillment with an initial (expandable) capacity of 100 million UIN

## DIFFERENTIATORS

**Only Company of Our Kind:** **MyPropertyID** is first-to-market with a globally unique identification number (UIN) for the government's smallest contractors and tiniest defense subcontractors. Our strategy is a miniaturized asset management system that exceeds the standards for labeling, recording and administering government furnished property (GFP). It uses responsive web design and does not require a 2D matrix, barcode or RFID scanner.

- Our strategy is a state-of-the-art solution that exceeds the property clause of the Federal Acquisition Regulation (FAR) 52.245-1(f)(1)(ii) to "stamp, tag, mark" GFP
- Our system exceeds the Defense Federal Acquisition Regulation Supplement (DFARS) 252.245-7001(b) that GFP receive a "tag, label, or mark."
- Our solution exceeds NASA's NFS 1852.245-74(c)(2) which states you must use a human readable "Unique Identification Number (License Tag)" affixed to GFP
- Our strategy complies with DFARS Case 2015-D035 (April 30, 2019) which requires compliance with FAR 52-245-1 for repair, maintenance, overhaul, or modification regardless of the unit acquisition cost
